At the regular meeting of the Board of Directors (BOD) of the Corporation held today, the following items were approved:

1. The declaration of cash dividends to shareholders of record as of October 21, 2021 payable on or before November 17, 2021:
 - a. Cash dividend of ₱ 0.0353 per share to all common shareholders;
 - b. Cash dividend of P0.0006 per share to all preferred shareholders representing 6% per annum cumulative dividends for the period July 1, 2020 to June 30, 2021.
2. A ₱ 5 Billion long term (up to ten years) facility with BDO Unibank, Inc. to partially fund CAPEX and other general corporate requirements.
